- A statement of not more than 300 words stating your reasons for wanting to attend college, university or trade school; your field(s) of interest; post-education plans; and your need for financial assistance.
- A letter of reference from a teacher, an employer, or any individual.

**Note: All current and former Delegate Norman Scholarship recipients need to re-apply each year.
